How many GW of prequalified battery energy storage systems are there?

Out of 6.9 GW of prequalified battery energy storage systems (BESS), equal to 1.9 GW derated capacity, about 1.8 GW of derated BESS secured 15-year contracts in the UK's T-4 auction - nearly double last year's volume.
