

Customs declaration for industrial and commercial energy storage cabinets

How to declare goods to Customs?

To declare goods to Customs, you must lodge the electronic declaration form first. The paper declaration form presented later, along with the attached documents, should be consistent with the electronic declaration form. This applies to both export and import goods, and can be done by consignors, consignees, or agent declaration enterprises.

What is a paper declaration form for import goods?

The paper declaration form for import goods shall be submitted in quintuplicate, consisting of five pages for different purposes: Customs operation, Customs record, enterprise record, Customs verification and writing-off, and certification (for import payment).

How to use a customs declaration form if taxes are leviable?

Article 15 In using a Customs declaration form to go through the Customs formalities for goods declared in Forms for Consolidated Declaration, if duties and/or taxes are leviable on the goods, the consignee or consignor shall also, in accordance with Customs provisions, go through the duty and/or tax payment formalities for the goods.

Who can handle declaration of import and export goods?

Only those who have obtained the qualifications as a Customs broker or have been registered at Customs are allowed to handle the procedure of declaration of import and export goods. The Customs brokers shall engage in declaration activities in accordance with the relevant laws, Customs regulations and rules.

What is a date of import/export in a consolidated way?

Article 18 In compiling Customs statistics, with respect to goods declared in a consolidated way, Customs shall take the "date of import/export" specified in the Customs declaration forms as the date of import or export of the goods.

How long do I have to declare goods to customs?

Article 8 The consignees of import goods and the agent declaration enterprises shall declare to Customs within 14 days as of the day when declaration is made for the arrival of the means of transport.
