The tender of CO<sub>2</sub> storage licenses in the North Sea is a step on the path to implementing the political agreements regarding the CCS strategy. The tender for licenses for the investigation of and storage of CO<sub>2</sub> is the first of its kind in Denmark. The tender is designed with an annual window for applications in the tendered area.
