Long-Duration Electricity Storage (LDES) refers to energy storage systems that can store and release electricity for long periods, typically eight hours or more. These systems help balance the supply and demand of electricity, especially when using renewable energy sources like wind and solar, which can be unpredictable.

Could 20GW of LDEs save the energy system £24 billion?

Government analysis has found that 20GW of LDES,the current target set for 2050,could save the electricity system £24 billionbetween 2030 and 2050,cutting household energy bills as additional cheap renewable energy reduces reliance on more expensive natural gas.

What technologies can be used for energy storage?

Other technologies include liquid air energy storage,compressed air energy storage and flow batteries,which are currently in development and would benefit from investor support. Large scale storage provides the grid with both security and flexibility to dispatch electricity to manage seasonable peaks or low renewable output over a period of time.
