A QFII must remit its funds into China within six months after being granted the investment quota by SAFE. If a QFII fails to remit the principal in full within the stipulated six month period and the amount actually remitted is more than the equivalent amount of US\$20 million, the amount actually remitted will be its investment quota.

Foreign investors holding QFII or RQFII approval are able to acquire the shares of any A-share listed company (subject to a cap of 30% on total QFII/RQFII ownership of a single company). The other options below either have longer lock-ups on each individual investment or offer access to a more limited A-share investment universe.

A custodian bank's main job is to safeguard all the assets that the QFII has put under its custody; conduct all QFII related foreign exchange settlement, sales, receipt, payment and RMB settlement businesses; supervise investment activities of QFII, and report to CSRC and SAFE in case QFII investment orders are found to have violated laws or regulations; and ...
