# Rohs certification for energy storage power supply

### What is RoHS compliance?

RoHS is an acronym that stands for the Restriction of Hazardous Substances. RoHS legislation originally developed in the EU,restricts the use of hazardous materials commonly found in electrical and electronic products. Since July 1,2006 all applicable products that are manufactured in,sold to or distributed in the EU must pass RoHS compliance.

### Does your product pass RoHS compliance?

Since July 1, 2006 all applicable products that are manufactured in, sold to or distributed in the EU must pass RoHS compliance. Since products are commonly sold or distributed to the EU or any other nation recognizing RoHS compliance, staying on top of the regulatory requirements is critical.

### Are power supply components RoHS compliant?

This means practically any power supply component could end up in the EU or another RoHS compliant nationand thus these standards need to be taken into account when assessing manufacturing processes.

### Do you need to label your products RoHS compliant?

While there is no required labeling needed to differentiate RoHS compliant products from non-RoHS compliant products, many companies have taken it upon themselves to label their products as RoHS compliant and tout the fact that they are RoHS certified.

#### Is pulse electronics power bu RoHS compliant?

Instead of manufacturing RoHS compliant parts for countries that have RoHS legislation or segmenting supply chains to only distribute to non-RoHS countries, it is more feasible to only manufacture RoHS compliant products.
