What are battery storage system tax credits?

Among the many provisions of the IRA, the introduction of battery storage system tax credits stands out as a major incentive for individuals and businesses looking to invest in energy storage solutions. These battery storage system tax credits aim to accelerate the adoption of energy storage technologies.

Why are solar & battery storage lease rates increasing?

Lithium batteries are eligible for the 30% Residential Clean Energy Credit, with an additional 10% tax credit if the energy storage system meets specific domestic content requirements. To qualify for this add-on, the system must adhere to guidelines ensuring that materials and manufacturing processes are sourced in the United States.

Does battery storage qualify for IRA tax credit?

Yes, standalone battery storage now qualifies for the 30% Residential Clean Energy Credit, introduced in 2023 under the IRA. This significant change means homeowners can receive a 30% tax credit for the installation of battery storage systems, even if they are not paired with new solar panels.

Why should you lease a site for a battery energy storage system?

Battery storage systems are a way of storing and releasing electrical energy in a chemical manner. Battery storage systems store the energy in batteries. An inverter converts the battery's DC energy to AC energy your home can use. The battery is charged using energy from your solar PV system or the electric grid.

The batteries can also provide demand services to host customers, by discharging to the customer when the customer's onsite load will peak. Host customers pay a monthly fee for this service. The battery owner must ensure that the battery is available when called by the utility, or the battery owner will be subject to penalties.
