Where did the 10-year warranty come from? According to Rahul Walawalkar, a storage expert, the 10,000 cycle was mostly about Lithium Titanate (LTO) batteries. But the 10-year warranty is for batteries with 3500 plus cycles. If we have 1 cycle per day, 350 cycles per year, it is 3500 cycles for 10 years. So, that"s the logic behind 10 year BESS warranty.
