

What is Yiwei lithium energy doing?

Up to now, Yiwei Lithium Energy has started the construction of nearly 100 GWh power storage battery projects in the industrial park, and cooperate with battery industry chain enterprises such as Enjie, Xinzhoubang, and Kedali to jointly build a new energy industry cluster of 100 billion yuan.

Will Yiwei lithium energy build Jingmen power storage battery industrial park?
